# 1 Vibration Monitoring


### 1.1 Real time monitoring


#### 1.1.1 Results


Real time vibration monitoring is conducted in 3 locations

- Busbys Bore Criteria of 5mm/s
- SCG Members Stand Criteria of 3mm/s
- South Eastern Boundary adjacent to Fox Studios adopted criteria of 7.5mm/s


Technical issues were experienced during the month which has resulted in some data not being available. Vibration loggers were used instead when works were being undertaken nearby to the Busbys Bore shafts and at locations on the boundary of the work site.

# 2 Noise Monitoring

## 2.1 Real time monitoring

- North East Boundary near Moore Park Road


The adopted criteria is as per the conditions of the Development Consent below:

C7. All works that generate noise exceeding 75dB(A) LAeq (15mins) are subject to the intra-day respite periods, as approved by the Planning Secretary in the CNVMP in condition B28

B28e(iv). the following intra-day respite periods (as defined by ICNG) for works exceeding 75dB(A) LAeq(15 mins), unless otherwise agreed with the identified sensitive receivers such as UTS, Kira Child Care Centre and / or Fox Studios and evidence of the agreement provided to the Planning Secretary, prior to the commencement of the works:

- in continuous blocks not exceeding 3 hours each with one hour of respite every three hours block;
- scheduling of works outside of the examination time for educational establishments; and
- noise intrusive works commencing after 8am and be undertaken within the approved standard construction hours.

2 Real time dust monitors are installed on the site


- North eastern boundary near Moore Park Road
